The Terms and Conditions of your appointment are as follows:

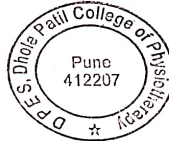

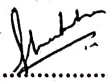

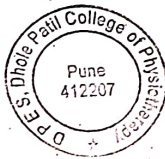
