Hereinafter referred to as 'The Sangam Sarvajanik Seva Samiti, which expressions shall include his successors, heirs, administrators, executors, assigns, representatives, etc.)

PARTY OF THE FIRST PART 01

AND

The Chairman, Dhole Patil Education Society, Dhole Patil College of Physiotherapy, Near EON IT Park, Kharadi, Dhole Patil College Road, Wagholi, PUNE-412207.

(Hereinafter referred to as the Dhole Patil College of Physiotherapy and Research which expressions shall include his successors, heirs, administrators, executor's assigns, representatives, etc.)

PARTY OF THE FIRST PART 02

Whereas the Sangam Sarvajanik Seva Samiti, Padmashree Late Annasaheb Beharay Jyeshtha Niwas, is a residential home for the aged people and is a charitable trust.

And

Whereas the Dhole Patil College of Physiotherapy is affiliated to the Maharashtra University of Health Sciences and is permitted by the Government of Maharashtra and Maharashtra State Occupational therapy and Physiotherapy Council, Mumbai.

And

Whereas the Dhole Patil College of Physiotherapy approached the The Sangam Sarvajanik Seva Samiti and expressed their desire to send their students as a part of their clinical practice at the Sangam Sarvajanik Seva Samiti, home for the aged by providing their physiotherapy services to their aged residents.

NOW THIS MEMORANDUM OF UNDERSTANDING WITNESS AS FOLLOWS:

AGREEMENT

1. That the Second year to final year students and interns of Bachelor of Physiotherapy Course of the Party of the Second Part will attend their clinical posting at the Sangam Sarvajanik Seva Samiti, home for the aged of the First Part.
2. That the Clinical Program would comprise of clinical posting for maximum 6 days per week (Expect Holidays and during Exams) from 9.00 am to 1.00 pm for students of the Dhole Patil College of Physiotherapy.
3. During their clinical postings students will be involving in the bellow mentioned academic

treatment session without affecting the privacy of the inmates. In-addition to the academic activities MUHS exams of said students also to be conducted with prior intimation to the in-charge of the Party One.

4. Both the parties have accepted that there shall be no financial liability from the either side.
5. The said college shall acquaint the students with the norms of discipline to be followed while on the premises of the said College First Part with appropriate notice that in case of any indiscipline by any of the students, the College First Part shall have right to restrict her/him from entering the premises of the said College First Part.

6. DURATION

- a. The duration of this understanding shall be for a period of Five Academic Years from the date of the execution of MOU i.e. 09.02.2023 to 08.02.2028 unless expressly extended, commencing from the date of its execution.
- b. Both the parties may cancel or terminate the present MOU by giving three months prior notice in writing to each other.

In Witness whereof, the parties hereto have signed and executed this AGREEMENT on the date herein before first mentioned. This agreement will be inforce from the admission student of Dhole Patil College of Physiotherapy from the academic year 2020-2021.

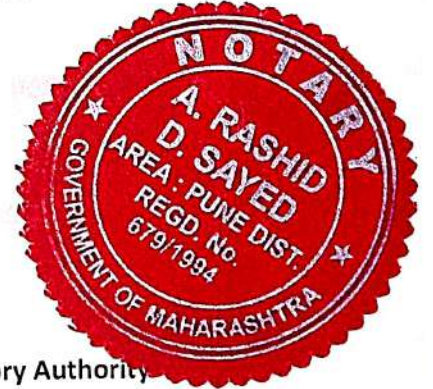
