Dhole Patil Education society and an Educational Public Charitable Trust through its college namely **Dhole Patil College of Physiotherapy**. DPES Campus Kharadi, Pune-411014 represented by its duly authorized signatory Mrs. Uma Sagar Dhole Patil, Secretary, (Dhole Patil Education Society and an educational Public Charitable Trust, Pune.)

Which expression shall unless there be anything repugnant to the subject or contrary to the context mean and include its present and future Trustees, their Heirs, Legal representatives, Executors. Administrators and Assigns, herein after referred to as College "Second part" for the sake of brevity) the party of the Second part.

WHEREAS **Dr. Anand B. Kulkarni, Principal BSDT's Ayurved Mahavidyalaya** Pune, is having the authority to execute contracts on behalf of Bharatiya Sanskriti Darshan Trust, Pune whereas the Bharatiya Sanskriti Darshan Trust, Pune owns and manages the college namely BSDT's Ayurved Mahavidyalaya within its territorial jurisdiction.

AND

WHEREAS **Mrs. Uma Sagar Dhole Patil, Secretary, DPES, Kharadi- Pune** is having the authority to execute contract on behalf of Dhole Patil Education society and an educational charitable trust kharadi Pune whereas Dhole Patil Education society Pune owns and manages the college namely Dhole Patil College of Physiotherapy within its territorial Jurisdiction.

Dhole Patil College of Physiotherapy established in the year 2020 duly approved by government of Maharashtra vid G.R No. PSO 2020/ P. NO. 57/20/ Shikshan-1 And Mrs. Uma Sagar Dhole Patil, Secretary of Dhole Patil Education Society has powers to enter into agreement for anatomy practical training of the 1st year BPTH students of Dhole Patil Education Society's Dhole Patil College of Physiotherapy, Pune-14.

(The said Colleges may be individually referred to as "Party" and collectively as Parties)

1. SCOPE

The Scope of this understanding extends only to send the students by the said College (Second Part) Up to intake capacity for all classes for imparting of anatomy practical training and examination as contemplated by the concerned syllabus for the discipline, in

batches each comprising of about 50 students accompanied by its faculty members to the said college (First part). And other incidental and ancillary matters related to it.

2. DURATION

2.1 The duration of this understanding shall be for a period of Five Academic Years from BPTH course 2021-22 unless expressly extended, commencing from the date of its execution.

2.2 Both the parties may cancel or terminate the present MOU by giving three months prior notice in writing to each other.

3. AGREEMENT

3.1 The FIRST PART hereby agrees and permits the said college SECOND PART to send students up to its intake capacity divided into different batches led by its faculty members to the said college for imparting of Practical training and examination of students as contemplated by the concerned syllabus.

3.2 The said college shall acquaint the students with the norms of discipline to be followed while on the premises of the said College First Part with appropriate notice that in case of any indiscipline by any of the students, the College First Part shall have right to restrict her/him from entering the premises of the said College First Part.

3.3 Both the parties have accepted that there shall be a professional charges of Rupees One Thousand per hour (1000/-) of the academic services offered from the first part to the second part.

In Witness whereof, the parties hereto have signed and executed this AGREEMENT on the date herein before first mentioned. This agreement will be inforse from the admission of first student of Dhole Patil College of Physiotherapy from the academic year 2021-2022.
