Differences in Interpretation and application:

Dhole Patil Education Society's Dhole Patil College of Physiotherapy, Kharadi, Pune and Buddy Centre will resolve any differences in interpretation and application of this working relationship through negotiation and round table discussion

Method of Cooperation:

Dhole Patil agrees to work with Buddy Centre to carry out the scope of work as defined above. Dhole Patil College of Physiotherapy will work with Buddy Centre to support in its true intent for project specific deliverables.

1. Nature of Relationship

Independent Parties

Nothing contained in this MOU shall be construed as creating an employer-employee relationship, partnership, joint venture, or agency between the parties. All personnel deployed by Dhole Patil College of Physiotherapy shall remain under its supervision, control, and responsibility at all times.

2. Scope & Supervision of Interns

Deployment and Supervision

Dhole Patil College of Physiotherapy shall ensure that all interns or students providing services at Buddy Centre do so strictly under the supervision of a qualified and licensed physiotherapist. Interns shall provide only supportive services and shall not independently diagnose, prescribe, or alter any therapeutic intervention.

3. Professional Responsibility & Clinical Decisions

All clinical assessments, therapeutic plans, and physiotherapy interventions shall remain the sole responsibility of Dhole Patil College of Physiotherapy and its authorized professionals. Buddy Centre shall not be responsible for any clinical outcomes or therapeutic decisions.

4. Insurance & Strengthened Indemnity

Dhole Patil College of Physiotherapy agrees to indemnify and hold harmless Buddy Centre, its trustees, staff, and volunteers from any claims, losses, damages, liabilities, or expenses arising out of negligence, misconduct, or professional errors by its staff, interns, or students.

Dhole Patil College of Physiotherapy shall maintain appropriate professional liability and medical indemnity insurance during the term of this MOU.

5. Child Safeguarding & Conduct

All personnel deployed by Dhole Patil College of Physiotherapy shall adhere to Buddy Centre's child protection and safeguarding policies. No child shall be left unattended with any intern or staff member, and all interactions shall occur in the presence of Buddy Centre personnel.

6. Payments & Records

Professional charges shall be mutually agreed upon in writing and paid on a monthly basis against an invoice raised by Dhole Patil College of Physiotherapy.

7. Confidentiality & Data Protection

Both parties agree to maintain strict confidentiality of all personal, medical, and developmental information of children and their families. Such information shall not be disclosed to any third party without prior written consent, except as required by law.

8. Termination with Notice

Either party may terminate this MOU by providing 30 days' written notice. In the event of termination, Dhole Patil College of Physiotherapy shall ensure appropriate transition or handover of ongoing therapeutic support to avoid disruption to the children.

9. Governing Law & Jurisdiction

This MOU shall be governed by and construed in accordance with the laws of India. The courts of Pune shall have exclusive jurisdiction.

10. "Limitations of Services"

Physiotherapy support under this MOU shall be limited to non-invasive, non-emergency therapeutic interventions conducted within Buddy Centre premises.

Indemnification:

Each party to this agreement shall indemnify and hold the other party harmless against any legal claims, damages, liabilities, or causes of action brought against them.

Memorandum of Understanding (MOU) Commitments:

Dhole Patil College of Physiotherapy and Buddy Centre recognizes the importance of collaboration to complete a set of activities as defined in this MOU.

Consequently, the parties are hereby establishing a working relationship for a period of 1 year from the date 16th November 2025 to 15th November 2026.

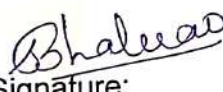


Terms and Conditions:
